# Please read complete contest rules below.

### Official Rules: "York Farm Fresh - Passport to Fresh" 2018

The York Farm Fresh – Passport to Fresh contest opens June 1, 2018 and **closes on September 30, 2018**. There will be one prize awarded.

#### **How to Enter**
